Agreement

Terms of membership include:

- 1. I must abide by the rules, policies and Bylaws of Sunsets West Co-op, as they may be amended from time to time. A copy of the current Bylaws was given to me on acceptance of my application.

- 3. If my account is inactive as defined by the Bylaws, my membership may be terminated.
- 4. Member cards are provided for my use and the use of my authorized dependents or proxies.
- 5. Membership certificates will be supplied.
- 6. If I am delinquent in equity payments or other financial obligations to the Co-op, I may have member benefits suspended.
- 7. The price of a member share and/or SSWC (Sunsets West Co-op) policies may be changed by the Board of Directors as the need arises.
- 8. Patronage dividends are paid at the discretion of the Board; only paid-in-full members are eligible to receive them. I am liable for any tax that may accrue in accordance with the Co-op's policy on dividends received by me as my share of membership.
- 9. Upon notice, I may sell my share (less any outstanding obligations) back to SSWC for the refundable portion of the membership fee. Shares are not transferable to third parties.
